

Lord Chief Baron Gilbert said, The answer still carries higher weight of probability along with it, because this is delivered in upon oath, and, therefore, over and above the single confession, it has an authority from the sanction of an oath. Gilb. Ev. 50. Mr. Phillips (1 P71. Ev. 341) gives the same reason for the exclusion of the bill and admission of the answer. It is notorious he observes, that many of the facts stated in the bill, are the mere suggestions of counsel, made for the purpose of extorting an answer from the defendant. The bills are not sworn to.
